



Mr. Fehmi Mehmeti Governor of the Central Bank of the Republic of Kosovo

Mr. Fehmi Mehmeti was elected on March 15, 2018, Governor of the Central Bank of the Republic of Kosovo, by the Assembly of the Republic of Kosovo, and on 26 March 2018 was appointed by the President of the Republic of Kosovo in the position of Governor of the Central Bank of the Republic of Kosovo.

Mr. Fehmi Mehmeti is also Chairman of the Executive Board of the CBK. On September 11, 2017, Mr. Fehmi Mehmeti has been appointed by the CBK Board, Acting Governor until the election of the new Governor. Whereas, on September 1st, 2013, Mr. Fehmi Mehmeti has been appointed, Deputy Governor of Financial Supervision at the Central Bank of the Republic of Kosovo.

As Deputy Governor of Financial Supervision, he was in charge of licensing, supervising and regulating financial institutions operating in the Republic of Kosovo, respectively banks, microfinance institutions, non-bank financial institutions, insurance companies, pensions funds and securities. At the same time, he was member of the CBK Executive Board.

Mr. Mehmeti graduated from the Faculty of Economics, University of Pristina in 1991. He earned a master degree on Financial Markets and Banking in 2012. During 1991-1992, Mr. Mehmeti worked in "Marin Beçikemi" high school in Vushtrri as lecturer of economic subjects, while during 1993-1998 he worked as Chief Accountant in commercial enterprise. During 1999- 2001 was enrolled in the Municipal Assembly of Vushtrri first as financial officer in Financial Department and then as Director of Health and Social Welfare Directorate.

During the period 2001-2011, Mr. Mehmeti had various positions in the Tax Administration of Kosovo, first at the regional office in Mitrovica, as a tax inspector, and later on at the General Directorate of Taxation in Prishtina, initially in the position of VAT Advisor and then as Manager of Tax Payers Audit. During his engagement on the Tax Administration of Kosovo, Mr. Fehmi Mehmet was actively engaged in the Kosovo tax legislation drafting.

During 2011-2013, Mr. Mehmeti got the position of the main Officer for Budget and Finance, Department of Finance and later on as Chief of Cabinet of the Chief Executive of Prishtina International Airport. During his engagement at PIA, Mr. Fehmi Mehmeti has actively participated in the drafting of PIA legislation. In the years 2010-2013, he held the position of Chairman of Board of the Public Enterprise "Uniteti" in Mitrovica.

At the same time, during 2011-2012 he was engaged as an external collaborator, Lecturer at the University of Pristina. He holds the title of "Certified Accountant" and has deep knowledge on the tax affairs and civil aviation issues. Governor Mehmeti was born on 05.06.1969 in the Beçiq village, Municipality of Vushtrri. He lives in Pristina with his wife Mrs. Fatime Mehmeti and their three children: Ermiri, Ermira and Ardian.
